RE: New B.C. Output-Based Greenhouse Gas Pricing System

Dear Ministers,

On April 4, 2023, we wrote asking for full and transparent consultation on the new B.C. Output-Based Pricing System (OBPS) policy framework. To date, we have not received a response from you.

In our April 4 letter (attached), we note BC's current carbon pricing structure does not compare favourably against domestic and international jurisdictions with which our energy-intensive, trade-exposed (EITE) natural resource and related downstream processing industries compete. We also flagged the need for a carbon pricing system that supports the competitiveness and long-term viability of BC's trade-exposed sectors, which generate most of the province's revenues.

The BC business community supports carbon pricing and the adoption of an OBPS model. However, as always with policy-related change, the details matter both from a program effectiveness standpoint and a relative competitive standpoint. The B.C. business community is concerned with recent consultations led by the GHG Regulator, which were deficient in essential details on the structure of the proposed B.C. OBPS, including matters such as benchmarks, tightening rates, thresholds for protection, offsets, and the use of regulated price as the floor price. These details are critically important, and the lack of transparency is of grave concern to the signatories of this letter.

The primary policy objective of an OBPS is to support the competitive position of trade-exposed industries and reduce the risk of carbon leakage. The change to a made-in-B.C. OBPS should deliver a material improvement to trade-exposed industries in B.C. and level the playing field with our Canadian and global competitors while continuing to incent reduced greenhouse gas emissions. This will help secure planned and potential investments in new and existing business operations. However, if the status quo remains, the potential for lost investment to lower carbon tax, higher GHG emitting Canadian provinces and international jurisdictions is very real. As the price of carbon emissions rises over time, the very viability of existing B.C. operations could be at risk. At stake are thousands of family-supporting jobs and contracting opportunities for Indigenous and local communities throughout B.C., along with long-term, secure funding for health, education, and government-funded services and programs.

We would be pleased to meet with you at your earliest convenience to discuss this matter, including, if necessary, under a non-disclosure agreement.
